Do you need an EPC contract for energy storage projects?

When developing an energy storage project, a project owner can either engage an EPC contractor to provide a fully-wrapped EPC agreement that will encompass the procurement, installation, and commissioning of batteries. In many cases, however, owners will contract directly with battery suppliers for battery supply and commissioning.

When do emergency procurement contracts come out?

In keeping with the District of Columbia's commitment to transparency in contracting and increased competition and in compliance with Rule 27-4719, the Department of General Services publishes emergency procurement contract information. All emergency awards are posted no more than 7 days after contract award.

What is the DC office of contracting & procurement (OCP)?

This portal is a public clearinghouse for all information related to the DC Government's contracting and procurement efforts. The DC Office of Contracting and Procurement (OCP) is required to post contract awards valued at \$100,000. Questions about doing business with the District government?

What happens if a battery procurement is delayed?

Delays in the procurement of batteries could lead to failures to comply with regulatory mandates, or, for utilities opting to install storage as NWA in place of other system upgrades, the failure to implement necessary system improvements.
