How do I report illegal construction?

You can also report illegal construction if the site appears unsafe for construction workers or it does not have a safety net or fence around it to protect those who live nearby. To notify the proper authorities, contact your local Building Inspection Department by phone.

How do I notify a building inspector if a construction site is illegal?

Most Building Inspection Departments will have contact numbers that you can use to notify them of an illegal construction site. The number may be toll-free or carry local charges. For example, in New York City, you can dial "311" to connect to the Building Inspection Department in your area.

Can a Hoa prevent a solar installation?

California's Solar Rights Act is among the strongest, prohibiting HOAs from preventing solar installations unless they pose safety hazards. Florida, Arizona, and Texas also have robust protections for homeowners wanting to go solar. However, HOAs can still impose certain reasonable restrictions. These typically include:
